By signing this registration form and participation waiver, it is agreed that:

1. I understand that Whitebridge Farm Productions, LLC is a Limited Liability Company registered with the state of New Hampshire. I agree to Whitebridge Farm Productions, LLC's exclusive right of the use of my name, likeness, photographs and other print, video, digital or electronic images, voice and music recordings, and written expressions of ideas and opinions (FYI - this does NOT include my script/play/screenplay that I will produce during the workshop), as produced for educational, publication, informational, or for use in advertisement, publication, website, promotion, sales and distribution, in any and all media that currently does and does not exist.
